Business Managers Report:

Financial Report: the net loss of \$6 thousand for the 1st fiscal qtr. ended September 30, 2013 basically mirrored last year's results. However, there were several sizable variances year-on-year in both the income and expense components.

Total income of \$549 thou exceeded last year by \$89 thou. The three contributing areas were Offertory (+\$51), Other Income (+\$24) and Non-Scheduled Income (+14). The increase in Other Income is primarily due to IRS refunds of \$12 thou resulting from the HealthCare Tax Credit program for the years 2010 and 2011, the reimbursement of \$3 thou in real estate commission due to the early termination of the lease at 37 Maple and \$5 thou in higher Religious fees. The increase in Non-Scheduled reflects higher Gifts & Bequests.

On the other side, expenses in the qtr. exceeded last year by \$86 thou. The category contributing to most of this was Supplies, Repairs, etc. (+\$59). Major projects this year totaled \$122 thou (paving & sealing \$27; school & gym roof repair \$77; reconstruction of school entrance \$18) compared to \$47 thou last year (school a/c \$25; Maple street window replacement down payment \$10; purchase of two computers and server \$12) for an increase of \$75 thou. This was offset by a decrease of \$19 thou in Religious Ed textbooks resulting from a payment being deferred to December. Services exceeded last year by \$6 thou due to higher Emmaus expenses and Utilities were \$17 thou more than last year due to timing of allocation of school costs by the Diocese.
